Explanatory Note

(This does not form part of the notification, but is intended to explain its general purport).

The Kerala Legislative Assembly passed "the Non-Resident Keralites welfare Act, 2008 (Act 10 of 2009)" for the constitution of a Welfare Fund to grant relief to, to ensure the welfare of and to pay pension and other benefits to the Non-Resident Keralites and to promote companies or co-operative societies

or other institutions of the Non-Resident Keralites' for their welfare. As per section 9(1) of the Act the Government may, by notification in the Gazette constitute a Board to be called "the Kerala Non-Resident Keralites Welfare Board" for the administration of the Fund and for the supervision and the management of the activities financed from the Fund and for other activities under this Act and the Scheme.

This notification is issued to achieve the above purpose.
